# Council 14 July 2016 Allocation of Seats on Committees

**Reporting Officer: Director of Governance** 

## 1 Purpose of Report

1.1 The purpose of this report is to make appointments to the Committees for the 2016-2017 municipal year in light of the by-election in Appleby (Appleby) ward and following the vacancy in Alston Moor ward.

## 2 Recommendation:

- 1. That the appointment of Members to Committees as set out in this report be approved.
- 2. That a revised Allocation of Seats on Committees report be brought to Council, pending the organisation and outcome of a by-election in Alston Moor.

## 3 Report Details

- 3.1 The seats on the Council's Committees should be allocated in accordance with the principles set out in the Local Government and Housing Act, 1989, to the political groups amongst the Members of the Council so far as is reasonably practicable. The principles seek to achieve proportionality in the allocation of seats. The principles, which are paraphrased, are in order of priority:
  - a) all seats on a committee cannot be allocated to the same political group;
  - b) the majority of the seats allocated on any body, including each Committee, are allocated to the group, if any, which has a majority on the Council;
  - the number of seats on the total of all committees allocated to each political group bears the same proportion as the proportion the membership of that group has to the membership of the entire Council; and
  - d) the number of seats on each committee allocated to each group bears the same proportion as the proportion the membership of that group has to the total membership of the entire Council.
- 3.2 The political composition of the Council is:

Conservative Group	20
Independent Group	10
Liberal Democrat Group	7
Vacancy	1
	38

The Conservative Group has an overall majority.

- 3.3 As Members will be aware, a by-election took place on 7 July 2016 in the ward of Appleby (Appleby) with Karen Greenwood (Independent Group) duly elected.
- 3.4 Members will also be aware that there is a vacancy in Alston Moor ward following the resignation of David Hymers which must be factored in to the overall political balance of the Council. A date for the by-election has been set as the 4 August 2016. Following the result of this by-election a further allocation of seats report brought to Council to reflect the new political balance.
- There are seventy-four seats on the seven Council Committees. The result of the by-election and the vacancy means that the Conservative group have forty seats. The Liberal Democrats have two seats on each Committee and the Independent Group make up the balance of seats.
- 3.5 The allocation of the seats to the political groups are as follows:

Conservative Group	40
Independent Group	20
Liberal Democrat	14
Vacancy	1

3.6 The Leader of the Council will be recommending changes to the Portfolio Holders on the Executive, which is considered elsewhere on the agenda. This has resulted in the Conservative Group having a vacancy on the Housing and Community Scrutiny Committee and the Environment and Economy Scrutiny Committee which will be filled by the group in due course.
