# Lic/10/9/15 Application for Premises Licence Lowther Barn Café, Beckside Farm, Sandwick, Martindale, Penrith, CA10 2NF

The Committee considered report CLS72/15 of the Director of Corporate and Legal Services which requested the Committee's consideration of an application to licence premises under the provisions of the Licensing Act 2003 in light of representations which had been received. The application was made by Mr A W Hewitt and Mrs M P Hewitt, trading as Alston Old Hall Farm, for Lowther Barn Café, Beckside Farm, Sandwick, Martindale. A licence had been requested permitting the sale of alcohol for consumption on the premises between the hours of 10am and 4pm daily, extending to 9pm during the hours of British Summer Time.
