Free Parking Days 2015 - 2016

1 Purpose of Report

1.1 To consider the provision of free parking at specific times during July, November, December and February 2015/16 in support of events in Penrith and Appleby.

2 Recommendation:

- 1. That the requested periods of free parking from 10.00hrs to 18.00hrs on 18 July, 14 and 28 November, 5, 12, 19 and 26 December 2015 and 27 February 2016 be approved.
- 2. That a supplementary estimate of £10,500 be approved.

3 Report Details

- 3.1 The Council has been asked to consider allowing free parking in its pay and display car parks to support local events including Penrith Goes Orange, Penrith on a Plate, Winter Droving and the Winter Festival. These requests have been made in order to support these events and also the local retail trade in Penrith.
- 3.2 The periods of free parking that have been requested are:

Saturday 18 July	Penrith on a Plate	10.00 - 18.00
Saturday 14 November	Winter Droving	10.00 - 18.00
Saturday 28 November	Winter Festival	10.00 - 18.00
Saturday 5 December	Winter Festival	10.00 - 18.00
Saturday 12 December	Winter Festival	10.00 - 18.00
Saturday 19 December	Winter Festival	10.00 - 18.00
Saturday 26 December	Winter Festival	10.00 - 18.00
Saturday 27 February	Penrith goes Orange	10.00 - 18.00

- 3.3 The requested charge-free periods would apply to the Council's pay and display car parks in Penrith at Bluebell Lane, Princes Street, Sandgate, Mansion House, Town Hall and in Appleby at Broad Close. They would also apply to the car park at Drovers Lane should charging be in place at any or all of the proposed times.
- The request for free parking to support events in the town was approved in previous years. The number of days on which free parking is requested has increased. The promoter has been requested to provide information on the effect of the provision of free parking on the events. The anticipated loss of income for all the days requested is £10,500 for which a supplementary estimate will be required. The 'loss' in the last financial year was £5,900.

4 Policy Framework

- 4.1 The Council has four corporate priorities which are:

- 4.2 This report supports the Quality Council corporate priority of economic vitality.

5 Implications

5.1 Legal

5.1.1 There are no specific legal implications.

5.2 Financial

- 5.2.1 Any decision to reduce or increase resources must be made within the context of the Council's stated priorities, as set out in its Council Plan 2015-19 as agreed at Council on 16 April 2015.
- 5.2.2 The proposed free parking periods will result in a direct loss of income to the Council. The potential loss of income is estimated at approximately £10,500.

5.3 Equality and Diversity

- 5.3.1 The Council has to have regard to the elimination of unlawful discrimination and harassment and the promotion of equality under the Equality Act 2010 and related statutes.
- 5.3.2 There are no specific equality and diversity implications.

5.4 Environmental
